***Cancellations, Substitutions, and Reschedule:***

States have detailed education, experience, and application processing requirements to qualify for licensing in the Asbestos field. Most states administer their own asbestos programs, and each state's Department of Environmental Protection/Health is generally the best place to start with questions about requirements and training. Some states may not accept Seagull Environmental training. Students are responsible to verify State requirements prior to registering for Seagull courses.

Training certificates are provided only after completion of the course and after you have passed your examination. Seagull certificates are typically given at the end of class. However, certificates may not be processed by Seagull until the next business day. In those cases, the certificate can be picked up from our training office in Arlington or we can mail them to the address provided on this form.

Once the original certificate has been issued and delivered, our obligation is complete as far as services rendered for payment. In most cases, honoring a request for a duplicate of an original certificate may require additional research time. As such, there is charge for each duplicate original certificate requested.
